TESTING

An individual currently employed as a Healthcare Mechanic with the appropriate years of documented experience may have the skills and ability to become certified. **It is mandatory that years of experience be an integral part of certification.**

Certification testing is scheduled at various test sites throughout California. Special testing accommodations can be arranged through the State Office. Orders for tests must be received at the CSHE office **one month** prior to scheduled test date. Contact CSHE (916) 552-7639 for details.
